for items listed in the grant proposal. The awardee reports on their research at the annual Fall Symposium held by the Native Plant Society of Texas by public lecture to the society's

members and attendees. The award amount of the Kate Hillhouse Scholarship is sent directly to the awardee's college and applied toward tuition costs. The awardee will also give a

lecture regarding their research or program of study at the Native Plant Society of Texas annual Fall Symposium.
